This six (6) months position will be based at Head Office (Observatory). The post will form part of the Adolescent and Youth Health Policy Short Course (AYHP SC) registered at the University of Cape Town (UCT) run by the DTHF with the London School of Hygiene & Tropical Medicine (LSHTM). The aim of the short course is to improve the health and wellbeing of adolescents in South Africa, through increasing capacity to implement interventions included in national policies. The Research Assistant will be expected to conduct a literature review on the overall health situation among adolescents in South Africa, and social determinants that drive the key problems in South Africa. This work will include materials from the 2017 and 2018 courses, placing it in context of adolescent health policy in South Africa. The results will be included in a session at the AYHP 2018 as an oral presentation and further produced as a written publication and/or journal article.

Requirements:

- Tertiary qualification in Health or Social Sciences or related field (~~Honours~~ and Master's Degree advantageous)
- At least three years research experience, in particular, involving the analysis and synthesis of quantitative data
- Ability to do extensive critical review and summarization of the published and unpublished literature with an understanding of determinants and health status data.
- Previous work experience in public health and/or social welfare related to adolescents and young people
- Proficiency in MS Office
- Excellent interpersonal and listening skills
- Excellent communication (Written and Oral)
- Inquisitive and non-judgmental attitude
- Demonstrated ability to work collaboratively as well as independently
- Excellent organizational and planning skills
- Ability to maintain a high level of confidentiality at all times
- Ability to work well under pressure and to maintain effectiveness during changing conditions

Responsibilities:

- To review, analyze and summarize existing data and information from government and academic sources in order to present the most important health conditions affecting young people (10-24 years old) in South Africa, and the most important social determinants of their health in the South African national context. This would include epidemiologic, demographic and socio-economic data disaggregated by age and gender, highlighting population groups at most risk and regional/provincial differences.
